

**The @Freebies4Mom And Power Rangers Dino Charge #PRDC Twitter Party
Sweepstakes Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.

The @Freebies4Mom And Power Rangers Dino Charge #PRDC Twitter Party Sweepstakes (the "Sweepstakes") is sponsored by SCG Power Rangers LLC ("Sponsor") and hosted by Lunchbox (the "Administrator") as well as @Freebies4Mom and her cohost @lomargie ("Hosts").

1. **Sweepstakes Period:** The Sweepstakes begins at 11:00 a.m. Eastern Time ("ET") on Wednesday, April 1, 2015 and ends at 12:00 p.m. "Noon" ET on Wednesday, April 1, 2015 (the "Sweepstakes Period"). The Administrator's clock will be the official timekeeping device for the Sweepstakes. By participating in the Sweepstakes, each participant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, including the interpretation of these Official Rules, which will be final and binding in all respects.
2. **Eligibility:** Open only to legal residents of any one (1) of the fifty (50) United States and the District of Columbia, who are eighteen (18) years of age or older at the time of entry. If a participant is eligible in his or her state of residence to enter as a minor, his or her parent or legal guardian agrees to these Official Rules along with and on behalf of the minor child. All rights and responsibilities of the minor under the Official Rules are

conferred and assumed respectively by the minor's parent or legal guardian in representation of the minor. 3. **How To Enter:** To enter, each participant ("Participant") must RSVP to the party on the Freebies4Mom blog by visiting <http://freebies4mom.com>, navigating to the #PRDC Twitter Party post and entering their name, email and Twitter URL into the widget on the page to receive one (1) entry (the "Entry") into the Sweepstakes. During the Sweepstakes Period, @Freebies4Mom and @lomargie will tweet about Power Rangers Dino Charge, the Power Rangers Dino Charge Power Strike Game on Walmart.com and Power Rangers Dino Charge gear at Wal-Mart. Participants must become a @Freebies4Mom and @lomargie follower on Twitter (if not one already) and accept @Freebies4Mom and @lomargie tweets and direct messages, then join the conversation by tweeting and including the hashtag #PRDC (the "Tweet.") The limit on the entire Tweet is 140 characters, including the hashtag. If Participant is a first time visitor to Twitter, Participant will be prompted to complete the on-screen registration form which is free. Registration is a one-time requirement. If Participant is a returning visitor, Participant will be prompted to log-in using Participant's e-mail address.

One Entry per person. Any Tweet or portion thereof that is, in the Sponsor's sole discretion, inconsistent with Sponsor's image, offensive, obscene, profane, lewd, defamatory, contains any proper names, third party materials, or otherwise violates or infringes (or may infringe) any copyright, trademark, logo, mark that identifies a brand (other than Power Rangers or Wal-Mart) or other proprietary right of any person living or deceased (including but not limited to rights of privacy or publicity or portrayal in a false light) or entity, or is otherwise objectionable, will not be accepted and may disqualify the Participant from further participation in the Sweepstakes.

The odds of winning a Sweepstakes Prize depends on the number of eligible Entries received. The random drawing will be conducted by the Hosts, whose decisions are final on all matters relating to the Sweepstakes. Winners will be notified via a public @mention and direct message on Twitter and will be required to respond to the initial prize notification by sending the hosts a direct message with their mailing address within five (5) minutes or the prize will be forfeited and a new winner may be chosen.
